ROLL CALL - Members present: Dave George, Ron Breitbach, Kathleen Scherrman, Jerry Sigwarth, Samantha Boyes and Steve Davis. Lisa Flanagan was absent. Staff Present: Ed Raber, Ben Kober and Amy Schmerbach.

APPROVAL OF MINUTES - A motion was made by Steve Davis, **seconded by Samantha Boyes to approve the minutes with edits of the April 21, 2026, meeting. The motion passed unanimously Vote: 5-0.**

Speaking to the board was Dave Schneider, Schneider Land Surveying. **A motion was made by Ron Breitbach, seconded by Jerry Sigwarth, to approve the rezoning of 2.886 acres more or less be rezoned to A-2, Agricultural/Residential for one home only and the remainder will stay A-1, Agricultural. Ben Kober said the Board of Supervisors approved ZC#04-06-26 Alvin & Kathryn Pothoff and Francis & Jayne Pothoff R-1, Rural Residential to R-2, Single Family Residential, ZC#04-07-26 Richard Oberbroeckling and Toboneous Moeggenberg R-1, Rural Residential to R-2, Single Family Residential, ZC#04-08-26 City Lake MHP, LLC and Justin Heim R-4, Multi Family Residential to R-2, Single Family Residential and the final plat for Wilwert Farm Subdivision Plat 3 were all approved by the Board of Supervisors.

NEW BUSINESS: Ben Kober told the Zoning Commission that when the Unified Development Code was finished it would come before them for recommendations to the Board of Supervisors. Mr. Raber talked about some changes that could be happening because of Supreme Court Updates that would affect some of the Zoning Commission's decisions. There was discussion about the Iowa Utility Commission and discussion on how other counties and states are handling the data centers. Ben Kober said that he has researched Linn Counties ordinance for Data Centers and explained how they handled them.
